## Information Sheet

### Project description

SUNRISE (Strategies and Technologies for United and Resilient Critical Infrastructures and Vital Services in Pandemic-Stricken Europe) is the EU-funded project that aims to facilitate active collaboration of Critical Infrastructure (CI) institutions across Europe to share best practices and jointly tackle future pandemics. With a group of 4 CI authorities, 16 CI operators, 3 other CI stakeholders, 4 experts in Social Sciences and Humanities, 2 experts in epidemiology and climate extremes, and 12 security researchers and software developers, we will:

1. Identify pandemic-specific vital services and CIs, their dependencies, risks, cascading effects, and effective measures to tackle them at European level.
2. Develop a comprehensive strategy and four innovative tools ensuring greater availability, reliability, security, robustness, trustworthiness, cost-effectiveness, climate-friendliness, and continuity of pandemic-specific vital services in Europe.
3. Pilot results in operational environments of the CIs while tackling some of their biggest pain points exposed by the current pandemic.
4. Promote our approach across Europe to ensure a united front and resilience of CIs to pandemics.

To support the project goals, SUNRISE is establishing stable working group (WG) on resilience to pandemics intended for cooperation, so that CI resilience and continuity can be viewed from the local, regional, national, and European level.

### Your participation in the WG

As a representative of one of the SUNRISE partners or as invited member in the WG we seek your help in:

- Understanding the functioning of the European CIs and cooperation mechanisms at international levels.
- Exploring and defining new ways of cooperation.
- Exchange best practices, discuss common issues, and find means to support each other in crises.
- Analysing pandemic- and climate-specific risks to CIs and cascading effects among them.
- Defining effective countermeasures considering social aspects and economic impacts.
- Implementing strategy developed by SUNRISE project for pandemic-specific risk assessment and mitigation.

We will also need to collect some of your contributions to the discussions for further analysis (see details in the Statement of Informed Consent and Permission to Use Information sheet).

## Data Protection & Management

SUNRISE relies on the participation of a range of stakeholders to obtain information about the project's focus. Participants will be participating in their professional capacity and as a representative of their organization. There remains a possibility that some information collected may be of a personal nature and must be treated as confidential.

To protect the privacy of participants and to prevent unauthorized access to data the project consortium will implement proper safeguard procedures. No personal data will be shared unless anonymized, and protocols will be implemented for the storage, access to and deletion of the information. The project will work in full accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation - GDPR).

## Privacy Policy

### Data Controller & Data Processors in the project

The GDPR defines the following roles in relation to the processing of personal data:

- Data Controller: Is a legal or natural person, an agency, a public authority, or any other body who, alone or when joined with others, determines the purposes of any personal data and the means of processing it.
- Data Processor: Is a legal or a natural person, agency, public authority, or any other body who processes personal data on behalf of a data controller.

For this WG, the data controller will be Institut Institute for Corporative Security Studies - ICS (details below) and there will be no data processors.

### Data Protection Considerations

The GDPR defines Personal Data as any information related to an identified or identifiable natural person. The Data Controller will collect some personal data related to the workshop participants, including the participants' name, gender, organization, position in the organization, email address, and opinions/contributions. Gender, organization and position will be used to describe the workshop participants. Name and email address will be used to contact the participant as a follow up until the end of the project. Your opinion/contributions will be used for further analysis and drawing conclusions.

The Data Controller will retain your Personal Data only for as long as is necessary for the fulfilment of the project goals.

Data Transfer: Your Personal Data will be processed by the Data Controller and its employers. They will not be transferred to any other organization.

However, the Data Controller may disclose your Personal Data in case of:

- Law enforcement: under certain circumstances, the Data Controller may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency)
- to comply with a legal obligation, protect and defend the rights or property of the Data Controller, protect against legal liability.

The legal Basis for Processing your Personal Data under GDPR is your consent.

The Data Controller undertakes to respect the confidentiality of Your Personal Data and to guarantee You can exercise Your rights.
